

BRISTOL MOTOR CLUB
SPEED CHAMPIONSHIP 2012
SUPPLEMENTARY REGULATIONS

1. The Bristol Motor Club will organise and administer the "Bristol Speed Championship" in accordance with the General Regulations of the Royal Automobile Club Motor Sports Association (incorporating the provisions of the International Sporting Code of the FIA), these Championship Regulations, the Supplementary Regulations of each qualifying meeting and any subsequent amendments officially promulgated and issued.

2. MSA Championship Permit No. CH2012/S060 has been issued.

3. The Championship is open to all paid up members of Bristol MC, holding an MSA Competitions License of National 'B' or higher grade. Registration will not be necessary and no fees payable, however only those members showing "Bristol MC" as their club on entry forms will be awarded points.

4. The Championship will consist of the following 5 qualifying rounds:

5. Competitors may compete in any car eligible for a class run at any of the qualifying rounds. No competitor may score points in more than one car or class at any one event. If a competitor enters more than one car at an event, the Championship Co-Ordinator shall record the better performance to calculate championship points.

6. a) In each class, in which a contender participates, the average best time will be calculated. For those whose time is better than the class average 15 points plus the improvement in the contenders' time over the average will be awarded. Where times are less than the average, the difference between the actual time and the average will be deducted from 15 points and the remaining points awarded

b) **No negative scores will be recorded.**

c) Bonus points (and parts thereof) will be added to scores achieved under (a) above. These will be based upon the extent to which the fastest time set in each class at any BMC event at each venue is bettered.

7. Competitors will count their best 4 scores from the 5 events. Ties will be resolved by reference to the contender scoring the points in the lesser number of events who shall take the place; failing which reference will be made to the number of highest scores; failing which the contender arriving at the counting score first; failing which by referring to the highest score in the discarded event; failing which organisers will determine a method.

8. Awards: The Simon Hemmings Memorial Trophy plus souvenir to 1st Overall. In addition there shall be an additional award for every 5 eligible competitors. "Eligible competitors" are those defined in the note below. The Club reserves the right to introduce additional awards at its discretion.

NOTE: To be eligible for any award, competitors must, in addition to scoring points as in 6 above, have officiated or marshalled at an event organised, or co-organised, by Bristol MC, during the championship year.
